

President's Report, September 2023



It has been an honour to be elected PANDDA President at the 2022 AGM and to serve as President over the last 12 months. PANDDAs advocacy, leadership and strategic activity, as outlined in the Strategic Plan, continues apace. Our membership pattern remains similar to previous years where some older members are not renewing their membership but gaining new and more diverse members.

Below is a summary of our activities and achievements over the last 12 months.

Membership

As is described below, PANDDA's membership is changing and although the overall 2023 numbers look like a 30% reduction on last year, there are several renewals being processed now and so these data will change in the coming week, or so. Crucially, although PANDDA is attracting new members, old members are not renewing. Potential reasons for these members not renewing (i.e., not being aware of the new "retired" category) should be explored with strategies developed to retain members. WA and the NT remain areas where PANDDA has not managed to generate reach or interest.

National Health Workforce Data Collection (AHPRA)

As I reported last year, "disability nursing" was added to the AHPRA annual health workforce survey after some targeted advocacy by PANDDA. Macey Barratt is giving an overview of these data at the conference and a journal manuscript is being prepared for submission to an appropriate journal by Dr Peter Lewis. This will be important and it will summarise this workforce for the first time since AHPRA was initiated.

Australian College of Nursing (ACN)

In 2021 PANDDA began working with the Australian College of Nursing to develop a specialist study subject in Intellectual and Developmental Disability Nursing.

In 2023 a single unit of study titled "Principles of Intellectual and Developmental Disability Nursing" was finalised and is now available as an elective subject within The Graduate Certificate in Aged Care Nursing and The Graduate Certificate in Community and Primary Health Care Nursing at the Australian College of Nursing.

This unit of study is designed for nurses who work with people with intellectual and development disability across their lifespan in a variety of settings from the home to hospital. The content covers the integral role of the nurse in building therapeutic relationships with the person and their support network. Students learn about the aetiology and epidemiology of various intellectual and development disabilities and how to support people living with them from diagnosis and as they transition to adulthood and older age.

The unit was written by specialist nurses, including some PANDDA members, for nurses. Students will be supported by a team of clinical experts, working within the specialty. This is a fantastic opportunity to build skills in this specialist area of nursing.

Every Nurses' Business - NDIS mainstream health system capacity building project

PANDDA remains a leading strategic partner on the "Every Nurses Business" project, which was extended through to July 2024. Led by Professor Andrew Cashin (Southern Cross Uni) and myself (Western Sydney Uni), this partnership also includes the Australian College of Critical Care Nurses, the College of Emergency Nurses, the Association of Primary Nurses, and the ANMF. PANDDA committee members have been supporting the online synchronous learning sessions and this continues to earn PANDDA some much-needed money.

National Roadmap on the Health of People with Intellectual Disability

PANDDA is represented on the Roadmap Implementation Governance Group (RIGG) and the Education Advisory Group, where I am a member of both.

The National Centre of Excellence has been awarded to a consortium led by UNSW, and PANDDA looks forward to working with the Centre into the future.

PANDDA Position Statements

The Committee acknowledges that the current position statements are potentially dated and need to be reviewed, but that there would be other areas that need to be explored as topics that may require their own position statement. Next steps will be consultation with PANDDA members and identification of writers. Below is the summary list that the Committee has drafted:

- 1. Research in NURSING in IDD care and Support
- 2. Credentialing Nurse in IDD
- 3. Reasonable Adjustments)
- 4. Role of the Nurse in IDD (we have Position Statement just needs updating)
- 5. Person Centred Practise (being the foundation of what we do)
- 6. End of life care
- 7. Emergency departments
- 8. Decision-making and informed consent for PWIDD
- 9. Nurse education
- 10 Restrictive Practices

Funded Research: Oral History Project

This is an important PANDDA funded project led by Dr Peter Lewis from WSU. Future funding of research projects will likely rely on grants and/or future income sources but should remain a core goal of PANDDA.
